RULES AND REGULATIONS

Refunds will not be issued. An exhibitor may sell his/her booth space to another exhibitor. However, the Central High School Annual Spring Fling officials require notification of such a change.

An exhibitor will be considered a NO SHOW if he/she has not arrived by 8:30 a.m. on Saturday. At that time, the booth space will be released for resale.

Set-up must be completed between 8-10 pm on March 14 and Saturday 7:30-9:30 am. Takedown must be completed by 3 p.m.

If a booth space is empty, it is not to be retained by another exhibitor without permission.

Vehicles may not park in the fire lane after loading/unloading supplies. You will be given a parking space and number the morning of your arrival.

Nails or anything that will mark the walls of the school may not be used. Tape is acceptable.

The show officials shall designate selling areas and each exhibitor shall sell and display within the confines of his/her designated area only.

The show officials reserves the right to restrict the sale, display or distribution of any printed materials, photographs, books, magazines, pictures, paraphernalia or other representations in order to maintain a proper, moral, wholesome environment.

The following will not be allowed for any reason: alcoholic beverages, amplifiers, or the sale of animals.

The Central High School 1st Annual Spring Fling officials reserve the right to refuse admission to any dealer.

The Keller ISD, its employees, the Central High School PTA, and Central High School, will not assume responsibility in the event of injury, accident or theft.

Any returned checks will incur a fee in the amount of \$25.00.

We **strongly** encourage exhibitors not to close their booths before 2:00 p.m. on Saturday.
